Staple yarns, twisted or not, in cotton, modal, viscose, polyester and their blends, cotton/elastane, flame retardant polyester, flame retardant polyester/viscose, bamboo viscose, bamboo viscose/viscose, bamboo viscose/modal, bamboo viscose/polyester, unbleached; cotton yarns, unbleached and mélange, also blends with polyester, black and white; dyed yarns in polyester, acrylic, cotton and viscose, also blends; mélange acrylic and polyester yarns also blends with viscose, cotton and modal, unbleached; unbleached or dyed acetate yarns; unbleached acetate/polyamide yarns; staple or continuous polyester filament yarns, twisted or not, unbleached, black; polyamide yarns, white and dyed; yarns in wool, cashmere, angora, silk, viscose, modal, lyocell, polyamide, polyester, flax, acrylic, PBT, elastane and blends, unbleached; polyamide/elastane and polyester/elastane yarns unbleached or black; yarns of polyester, flame retardant polyester, viscose, flax and blends, unbleached, also blends with polyester, raw and dyed; unbleached yarns of cotton, viscose, flax, polyester, acrylic, polyamide, modal and their blends. Polyamide 6 and 6.6 staples, matt, super matt, shiny or solution-dyed in grey and black, siliconized or not. Unbleached viscose fiber, shiny, matt or dyed. Raw materials pre-certified according to STANDARD 100 by OEKO-TEX® - partly produces with fibres having flame retardant properties accepted by OEKO-TEX®

The results of the inspection made according to STANDARD 100 by OEKO-TEX®, Annex 4, **product class I** have shown that the above mentioned goods meet the human-ecological requirements of the STANDARD 100 by OEKO-TEX® presently established in Annex 4 for baby articles.

The certified articles fulfil requirements of Annex XVII of REACH (incl. the use of azo colourants, nickel release, etc.), the American requirement regarding total content of lead in children's articles (CPSIA; with the exception of accessories made from glass) and of the Chinese standard GB 18401:2010 (labelling requirements were not verified).

The holder of the certificate, who has issued a conformity declaration according to ISO 17050-1, is under an obligation to use the STANDARD 100 by OEKO-TEX® mark only in conjunction with products that conform with the sample initially tested. The conformity is verified by audits.
